# Statutory Role of Housing Associations - Origins

- 1999 – Homelessness Task Force set up
- 2000 – Interim Report
- 2001 – Housing (Scotland) Act
- 2002 – Final Report
- 2003 – Homelessness (Scotland) Act

# Housing (Scotland) Act 2001

- Each LA had to assess levels of homelessness and prepare a homelessness strategy
- Applicants had to be given temporary accommodation while their case was investigated
- Priority need applicants were entitled to permanent accommodation
- 'Threatened with homelessness' period was extended to two months
- Offers of accommodation had to be reasonable and meet any special needs
- **HAs now had a duty to allocate to homeless people referred by councils (Section 5 referral system)**

## The Homelessness (Scotland) Act 2003

- Priority need' to be extended in stages. By 2012 there will be no distinction between different priority groups
- People who make themselves 'intentionally homeless' will get temporary accommodation

Task Force also made 59 final recommendations, 54 of which related to changing policy & practice.



## Some Section 5 Statistics (2006/7)

- 2,700 homeless people housed
- This is 16.0% of all association allocations
- Around 6000 referrals, success rate around 50%

....however, this is only part of the picture....

## ‘Non-Statutory’ Contribution by Associations

.....there are other routes into association stock for homeless people.

- All association allocations policies must give reasonable preference to homeless (1987 Act)
- CHR commonalities exercise – homelessness given highest priority in almost every association policy
- 40% of WL allocations prevent homelessness!!
